Doma Title Insurance, Inc. appoints Christina Blum as Vice President, Regional Underwriting Counsel for Texas, Louisiana and Oklahoma

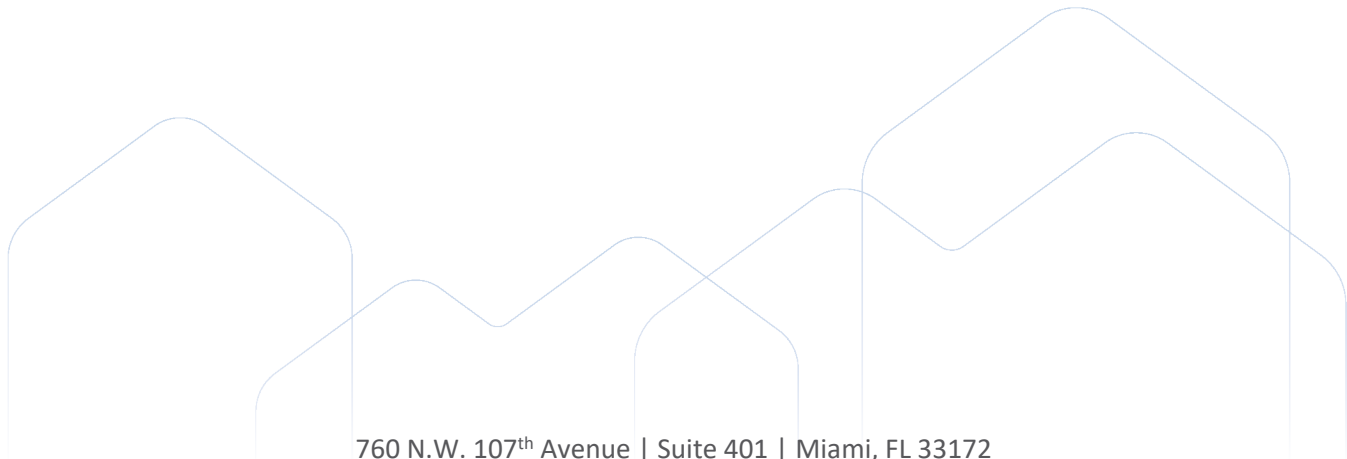
